

## 二、自行查核實作篇

- 依據：遠洋漁業漁獲物或漁產品出口業者核准及管理辦法

(第9條)

遠洋魚貨出口業者採購、銷售附件一所列遠洋漁業漁獲物或漁產品，應遵守其所訂定之行為規範及作業流程，**每年至少執行自行查核一次**，並於每年(N)一月二十日前，將前一年(N-1)之自行查核報告送主管機關備查。

At its Annual Meeting in October 2007, SEAFO Commission has adopted a [Conservation Measure 08/06](#) to ensure that IUU fishing in the whole of Atlantic Ocean is minimised. In so doing, the Commission has adopted a measure to list IUU vessels that are in the IUU lists of Northwest Atlantic Fisheries Organisation (NAFO), Northeast Atlantic Fisheries Commission (NEAFC) and the Commission for the Conservation of the Antarctic Living Marine Resources (CCAMLR). 
